

Accounting Manager Position Description

The Houston Health Foundation Accountant position is a full-time position charged with performing the day-to-day accounting functions of the organization, as well as reporting and liaising with development staff, program managers, and partner organizations.

Responsibilities:

- Maintain foundation's QuickBooks accounting software system
- Accounts Receivable: record all revenue in the general ledger according to Non Profit accounting standards
- Accounts Payable: work with HHD program managers to initiative expenditure requests, obtain appropriate approvals, and record expenditures in general ledger.
- Reconcile bank statements with general ledger and close the monthly financial statements
- Generate monthly and annual financial statements including monthly cash projections
- Manage and reconcile credit card account
- Work with audit firm to provide all relevant records for annual independent audit
- Provide all relevant information to CPA firm for tax preparation
- Generate fund account statements on a monthly basis and distribute to fund managers
- Make recommendations for improvements to accounting policies and procedures

Qualifications:

- Hands-on experience in accounting or other related fields
- Fundamental knowledge of GAAP and non-profit accounting standards
- Experience with Quick Books and Intuit
- Detail and deadline-oriented
- Strong analytical and problem solving skills
